



IAQTI Contractor's Guide to Certification

The IAQ Training Institute, LLC provides Indoor Air Quality Association (IAQA) approved training courses that can stand alone as proof of attendance at a training program and/or as certification exam prep course. Our programs also prepare people for ***third party accredited** certifications or state licensing programs. Some state licensing programs require third party accreditation. Third party accredited certifications can NOT require a specific training course prior to certification but they can and do require verification of one's level of experience and education. Some state licensing programs do require verification of training and/or third party accredited certifications. IAQA/IAQTI course certificates are accepted in most states.

IAQ Training Institute could have taken the easier (and more lucrative) path of claiming to “certify” people that attend our courses, but we have chosen a different path and it has served our clients well. See why under the Benefits of Attending section of this document.

The following tables summarize the major certification programs IAQTI mold remediation training courses prepare attendees for. We do not recommend or support any other certification programs specific to indoor environmental quality or mold remediation. Most of these programs are really a training course with an exam and claims of certification. True certification is more complex and is the reason for this document.

Benefits of IAQA/IAQ Training Institute training programs!

The certifications we prepare people for are through the American Council of Accredited Certification (ACAC) and one specific certification from the Institute for Inspection Cleaning and Restoration Certification (IICRC). ACAC certifications are third party approved and meet ASTM standards for "true" certification programs. As a result state licensing programs have accepted ACAC certifications for grandfathering purposes. In addition ACAC certification exams are now used as the Florida DBPR mold licensing exam. Most IICRC certifications are not third party approved. The one certification IICRC is working on getting third party approved is the Mold Remediation Specialist (MRS). Read more about that certification on the next page. The other IICRC certifications are good programs and may be the best available in many categories, but they are not third party accredited.

IAQA/IAQ Training Institute courses are approved by the Florida DBPR to meet the training requirement in their state regulation while also helping prepare attendees for the Florida state mold licensing exam which is administered by the ACAC. IAQA/IAQ Training Institute courses are approved as proof of education for Louisiana mold licensing. IAQTI courses were approved by the state of Virginia, during the time VA had a licensing program. ***What is Third Party Approval?**

The American Society for Testing and Materials (ASTM) Standard E 1929, Assessment of Certification Programs for Environmental Professions: lays out the criteria for how certification programs become third party accredited. Three organizations in the US most commonly approve certification programs for example the Council of Engineering and Scientific Specialty Boards (CESB) has established a national reputation for accrediting certification programs in engineering and science-related fields. CESB-accredited programs that



you may recognize include the Certified Industrial Hygienist (CIH) and Certified Hazardous Materials Manager (CHMM). ACAC offers the only CESB-accredited programs dedicated to the field of indoor air quality. The other US third party approval groups are American National Standards Institute (ANSI) and the Institute for Credentialing Excellence (ICE), formerly known as NOCA. The best known worldwide third party accrediting organization is the International Organization for Standardization (ISO).

Why is Third Party Accredited Certification Important? High Standards

According to CESB, certification is designed to recognize knowledge and verified field experience. Accredited certification programs must therefore require both. In order to qualify for CESB accreditation, a certification program must also meet high standards of program operation:

- It must be administratively independent of other organizations in matters pertaining to certification;
- Its certifying body must consist of a majority of certified individuals;
- It must provide the public and consumers with an opportunity for input into its policies and decisions;
- It must follow strict rules for public disclosure of certification-related activities;
- It must follow strict rules for test development, evaluation and administration;
- It must enforce stringent eligibility requirements for all candidates, including eight years of education and/or field experience for engineering-related designations.

****The IICRC Mold Remediation Specialist (MRS)**

The IICRC is working toward third party approval of their Mold Remediation Specialist (MRS) certification through the American National Standards Institute (ANSI). This is partially the result of not being accepted in Florida for grandfathering into the Mold Remediation Contractor licensing program. The only certification accepted by Florida at this point are the ACAC certifications for microbial remediation supervisors. Maryland's Home Improvement Commission (HIC) will begin enforcement of their mold licensing regulation in July 2013. The law requires ACAC or equivalent certifications. There are no equivalents at this point.

At the time this document is being written IICRC has completed beta testing of their proposed exam for mold remediation specialists. They have also established a one year experience requirement. We will update this document as they move along in the process of becoming ANSI approved. There is no specified time frame for approval and the process commonly takes years as opposed to months.

The IICRC has another "certification" program for mold remediation technicians and supervisors. The existing Applied Microbial Remediation Technician (AMRT) and (AMRS) Supervisor programs are good educational programs with an exam at the end of the 4-day AMRT. It also requires attendees have taken and passed the IICRC Water Restoration Technician (WRT) training course/certification. This program is not third party approved and requires a specific IICRC training course to acquire the certification. It is however a certification that is commonly recognized by insurance companies as are all ACAC certifications.
